### Report of ULCC Past President Sarah Dafoe, Alberta



And just like that, the ULCC's 105<sup>th</sup> annual meeting has come and gone. Delegates to the annual meeting were welcomed warmly in Charlottetown, PEI, and as you'll see in the reports from Christine Badcock and Annie Bernier, a considerable amount of work was

completed by both the Criminal Section and the Civil Section. In addition to the Sections' work, attendees received updates from the ULCC's Roles Review Committee, Diversity and Inclusion Committee, Communications Committee, and Environment and Climate Crisis Committee.

Our week in Charlottetown was a success, thanks to engaged and enthusiastic delegates and presenters, and also because of the thoughtful and diligent preparations of our Island hosts, the Section chairs, the Executive Committee and, in particular, our Executive Director, Michelle Lemieux. In addition to our productive daily meetings, delegates were able to catch up with their colleagues on a social basis at the various evening events. At our opening reception, we were honoured to be welcomed by the Honourable Bloyce Thompson, PEI's Minister of Justice and Public Safety and Attorney General, as well as by Loretta Coady MacAulay, K.C., from PEI's Department of Justice and Public Safety. In addition, Cindy Cameron provided greetings on behalf of the Law Society of PEI. This traditional event was renamed this year: it's now called the Clark W. Dalton, K.C. Reception, in honour of our former Project Coordinator and longstanding colleague who passed away unexpectedly earlier this year. Clark played many roles with the ULCC over his almost 40 years of involvement with this organization. While his primary focus was to support the work of the Civil Section, he was devoted to the whole of ULCC. He was involved in everything from website renewal to constitutional and bylaw amendments, and he wrote a first draft on the history of the ULCC going back to its formation in 1918. Most importantly, though, Clark enjoyed the informal hallway chats, connecting with people on an informal basis and learning about their lives. The Executive Committee thought that renaming the opening reception in Clark's memory was very appropriate. He was one of a kind and we miss him.

Another longstanding tradition is the annual East versus West softball game, which this year was held in Victoria Park, near the harbour in Charlottetown. The host committee somehow arranged for gorgeous weather and a beautiful sunset to help the East team celebrate their victory while also soothing the spirits of the West team. # 2022-2023 Criminal Section Chair Anny Bernier, Québec

It was a privilege to chair the Criminal Section meeting this past summer in Charlottetown. We had a full agenda this year and some very interesting presentations in our open forum, which I would like to highlight for everyone.

The Criminal Section had a very rewarding week of meetings and an excellent turnout of 36 delegates participating in the deliberations of the Criminal Section, coming from 12 provincial, territorial, and federal governments. The Section considered 33 resolutions on a wide range of criminal justice topics, including the possibility of establishing a working group related to the severity of punishments for murder committed against an intimate partner. Following very constructive discussions and several amendments, 29 resolutions were adopted, which included resolutions proposing to increase the maximum penalty for voyeurism and non-consensual distribution of intimate images; to have constructive firstdegree murder in home invasion cases; and to examine Part XX.1 of the Criminal Code to allow the court to consider the issue of fitness of the accused to stand trial at any stage of the proceedings.

During the week, the Criminal Section also received the final report of the working group on the search warrant

regime under section 487 of the *Criminal Code*. Progress reports were received by three other working groups, on section 672.26 of the *Criminal Code* regarding juries and fitness to stand trial; detention of seized property under section 490 of the *Criminal Code*; and examination of the treatment of animals in the *Criminal Code*. As well, a motion was passed to set up a joint working group for criminal and civil legislative recommendations on the treatment of animals.

This year, the Earl Fruchtman Memorial Seminar featured a presentation by John Diamond, K.C., the Director of Prosecution for Prince Edward Island, where Mr. Diamond spoke about a number of the province's initiatives, including alternative measures. The dynamic session was attended by the delegates from both the Criminal and Civil Sections.

After what was a truly enjoyable, productive, and particularly enriching week, I completed my mandate as Chair of the Criminal Section by handing the torch over to Craig Savage. I know that Craig will do a great job as Section Chair for 2023-2024. I thank Aleksander Godlewski for his incredible support and outstanding work since his appointment as Criminal Section Secretary in early 2023. A warm thank you as well to 2022-2023 President Sarah Dafoe, Civil Section Chair Christine Badcock, Executive Director Michelle Lemieux, and the members of the Criminal Section Steering Committee for their invaluable assistance and collaboration throughout the year. I look forward to working with my successor and seeing everyone again next year!



#### 2022-2023 Civil Section Chair

The 105<sup>th</sup> annual meeting of the Civil Section was held in Charlottetown this past August. Meeting delegates from provincial, territorial and federal justice

departments, academia and law reform bodies all attended. We were also pleased to be joined by Mr. Carl Lisman, Past President of the Law Reform Commission (ULC) in the US. At the annual meeting, the Civil Section adopted the *Uniform Enforcement of Canadian Judgements Act*. Arising from the adoption of the new act, the former Act (the *Uniform Enforcement of Canadian Judgements and Decrees Act*) was withdrawn. The working group reviewing the Act was ably led by Professor Stephen Pitel and we thank all members of the working group for their hard work.

The Section also adopted new Drafting Conventions following a review led by Professor John Mark Keyes. The previous version of the Conventions had been adopted by the ULCC back in 1989, so their modernization was definitely in order. We are grateful to legislative drafting offices from around the country for their participation in the working group reviewing the Conventions.

The Section also adopted, in principle, a proposal to make amendments to the *Uniform Benevolent and Community Crowdfunding Act* (UBCCA). These minor amendments arise from a review conducted after the adoption, last year, of the *Uniform Gratuitous Crowdfunding Act* (UGCA), the civil law version of the UBCCA. The amendments aim to ensure harmonisation between the UBCCA and UGCA. The revised UBCCA will be circulated to the jurisdictional representatives by the end of October, and adopted if no objections are received by November 30, 2023.

As well as adopting these three projects, the Section received status reports on ongoing projects related to non-disclosure agreements, the reform of partnership law/joint ventures, and charitable organizations. The Section provided direction to the groups working on these projects and expects to receive further updates at the next annual meeting in August 2024.

Additionally, the Section received a pre-implementation report on the *Hague Convention on the Recognition and Enforcement of Foreign Judgements in Civil or Commercial Matters (2019),* an update on private international law initiatives from Justice Canada, and an update from the ULC on its current projects.

The Section adopted a new policy tabled by the Civil Section Steering Committee's Sub-Committee on Rules of Procedure and Policies. The *Policy on the Distribution of Materials to the Civil Section for its Annual Meeting* is designed to ensure that delegates to our annual meetings have adequate time to consider, analyze and consult on materials that will be presented at the annual meeting. The Sub-Committee continues its work and expects to submit a policy concerning Reports Presented to the Annual Meeting at the next annual meeting.

The Section received a report from the Advisory Committee on Program Development and Management (ACPDM) setting out the work cycle of the ACPDM and identifying ongoing and possible future projects. As well, delegates shared updates on the implementation of ULCC uniform acts by their jurisdictions. Finally, in a joint session with the ULCC's Criminal Section, the ULCC considered establishing a joint working group to review the treatment of animals in Canadian law.

The annual meeting also provided an opportunity for us to remember our colleague Clark Dalton, K.C., Project Coordinator, who passed away in February, and to celebrate his contributions to the ULCC.

It was a pleasure to serve as Civil Section Chair this past year and I am excited to have the opportunity to continue in the role for another year. The role is made easier with the support and assistance of Michelle Lemieux, Executive Director; Peter Lown K.C., Chair of ACPDM; and our Executive Committee and jurisdictional representatives. I look forward to working with them and Christina Croteau, our new Legal Project and Research Coordinator, over the coming year.

## President's Report

When I attended my first meeting of the Uniform Law

I anticipated a very formal, rigid meeting with clear jurisdictional divides and positions dictating the outcomes of the discussions. What I discovered instead was a group of extraordinary individuals engaged in lively and collegial debate, driven by a shared passion for the law and a desire to improve it for all Canadians. Now, armed with almost a decade of experience with the ULCC, and with a much better understanding of its purpose, processes, and people, I can say that it is truly a humbling experience to have the privilege of taking on the role of President for 2023-2024.

During my tenure as President, I look forward to continuing the important work started by my predecessors in a number of areas. First, I will continue to explore potential options for using technological solutions to enhance access to our annual meetings. This is a discussion that has been underway for a number of years, and one that remains a priority. Second, I look forward to supporting the ongoing work of the Roles Review Committee as it continues to examine the structure of the Advisory Committee on Program Development and Management (ACPDM) and considers the role and responsibilities of its Chair going forward. More work remains to be done, but I am confident that the creativity and dedication of the members of the Roles Review Committee will produce excellent suggestions to guide the ULCC into the future.

In addition to these ongoing priorities, I intend to focus on two additional main priorities in the coming year. First, I will work with the Executive Committee and the Budget and Finance Committee to take a close look at the ULCC's finances. Responsible stewardship of the financial support provided by provincial, territorial, and federal governments is essential, and I plan to focus on setting out a roadmap to ensure fiscal stability and sustainability going forward. Second, I plan to focus on the ongoing goals of increasing diversity and inclusion within the ULCC. The Diversity and Inclusion Committee has produced a report setting out a number of recommendations, and I intend to work with the Executive Committee to implement as many of those recommendations as possible.

The ULCC has experienced a number of significant challenges over the past few years, weathering a global pandemic that resulted in two virtual annual meetings, experiencing turnover at the Executive Director level and, sadly, losing longtime Project Coordinator, Clark Dalton, K.C. While these events have been difficult, they demonstrate the resilience and adaptability of the ULCC as an organization. Recognizing all that has come before, and looking forward, it is a privilege and an honour to have the opportunity to lead the ULCC into the exciting year ahead.

In closing, I would like to extend a sincere thank you to everybody involved in the work of the ULCC. Whether you are a member of a committee, a jurisdictional representative, a delegate or a member of a working group, your ongoing support and involvement are very much appreciated. Nothing that the ULCC has accomplished in the past, or will no doubt accomplish in the future, would be possible without you.
